Sir/Madam,

The case No. 1618/20/18/2024 in respect of ASIF ABID KHAN, was placed before the Commission on 07/07/2025. Upon perusing the same, the Commission directed as follows:

1. These proceedings shall be read in continuation of earlier proceedings of the Commission.
2. The complainant has stated that a woman Mamta, resident of Keharpura Kalan village of Jhunjhunu, Rajasthan, was admitted in Rajiv Hospital, Chirawa on 13th August 2024 due to labour pain. On 14th August 2024, Mamta gave birth to a healthy baby. Initially her condition was reported to be stable, and the family was happy. However, shortly after, the doctors at the hospital informed that Mamta had suffered a heart attack, which led to her death. As the family noted something suspicious, they refused to take Mamta's body from the hospital for 24 hours. Subsequently, when the postmortem report was received, and it became clear that Mamta died due to excessive bleeding and shock. As per the complainant, this shows serious medical negligence on the part of the hospital staff, but no concrete action has been taken by the police. He has requested intervention of the Commission to ensure stringent action against the guilty persons.
3. The Commission vide proceeding dated 17.10.2024 took cognizance in the matter and directed the Principal Secretary, Department of Health & Family Welfare, Govt. of Rajasthan, through online mode, to have the allegations inquired, ensure the needful action and submit the action taken report to the Commission within six weeks.
4. However, there was no response. Hence, reminders dated 03.02.2025.
5. The Commission has considered the material placed on record. The Commission vide its proceeding dated 17.10.2024 had directed the Principal Secretary, Department of Health & Family Welfare, Govt. of Rajasthan, to submit action taken report within four weeks; however, there has been no response despite reminder dated 03.02.2025.
6. Hence, in such compelling circumstances, the Commission has no other option left, except to invoke Section 13 of Protection of Human Rights Act, 1993. Therefore, the Commission directs its Registry to issue **Conditional Summons** u/s 13 of Protection of Human Rights Act, 1993, to the **Principal Secretary, Department of Health & Family Welfare, Govt. of Rajasthan**, to appear before the Commission on **11.08.2025 at 11:00 AM** with requisite Action Taken Report, should however, if the requisite reports received in the Commission one week prior to the scheduled date then personal appearance of the Principal Secretary, Dept. of Health & Family Welfare, Govt. of Rajasthan, shall be dispensed with. However, if the Principal Secretary, Dept. of Health & Family Welfare, Govt. of Rajasthan, fail to comply with the order of the Commission without lawful excuse, Principal Secretary, Dept. of Health & Family Welfare, Govt. of Rajasthan, will be subject to the consequences of non-attendance laid down in Rule 10 and Rule 12 of order XVI of Civil Procedure Code, 1908 including issuance of bailable warrant of arrest.
